#### **Migrants in Ireland**

#### Census 2011

544k non-Irish in Ireland, Western Europeans and North America: approx 158k, Eastern Europe: 221k, the rest 164k. **Polish diaspora: 122k.** 

#### Census 2016

535k non Irish in Ireland, Western Europeans and North America: approx 160k, Eastern Europe 258k, the rest: 117k. **Polish diaspora: 122k** 

<u>Relatively significant amount of citizenship receipients (2010-2016) amongst third</u> <u>courntry Nationals could impacted overall data.</u>







#### **Racism and discrimination**

Anti-Racism Committee interim recommendation

- **1.** Remove reservation to article 4 of CERD
